



## U.S. government obligations information

### Important tax information for 2018

This tax update provides information to help you properly report your state and local tax liability on income distributions you received from your mutual fund investments in 2018.

On the reverse side, you'll find a list of Vanguard funds that earned a portion of their investment income from obligations of the U.S. government. (You can find U.S. government obligation information for Vanguard Institutional Target Retirement Funds online at [advisors.vanguard.com/taxcenter](https://advisors.vanguard.com/taxcenter).) Direct U.S. government obligations and certain U.S. government agency obligations are generally exempt from taxation in most states.\* To the right of each fund name, you'll find two columns:

- **Column 1. Percentage of the fund's total *income* derived from U.S. government obligations in 2018.**  
Check with your state or local tax office or with your tax advisor to determine whether your state allows you to exclude some or all of the income you earn from mutual funds that invest in U.S. government obligations. If your state allows an exclusion, refer to this column for the percentage of income that may be excluded for each fund in which you're invested.\*\*
- **Column 2. Percentage of the fund's *assets* invested in U.S. government obligations as of December 31, 2018.**  
Certain states and municipalities require residents to pay intangible or personal property tax. If you're required to pay either of these taxes, refer to this column for the percentage that may be excluded from these taxes for each fund in which you're invested.

\*Investments in U.S. government obligations may include the following: Banks for Cooperatives, the Commodity Credit Corporation, the Federal Deposit Insurance Corporation, Federal Farm Credit Banks, the Federal Financing Bank, Federal Home Loan Banks, Federal Intermediate Credit Banks, Federal Land Banks and the Federal Land Bank Association, the Federal Savings and Loan Insurance Corporation, the General Insurance Fund, the Government Services Administration (GSA Public Building Trust Participation Certificates), the Production Credit Association, the Student Loan Marketing Association, the Tennessee Valley Authority, the U.S. Postal Service, and the U.S. Treasury Department (bonds, notes, bills, certificates, and savings bonds). GNMA securities aren't U.S. government obligations.

\*\*The percentages provided apply only to income distributions (dividends); they don't apply to capital gains distributions (whether long-term or short-term).
